# What is the GDSN?


## Global Data Synchronization Network

- The GDSN is an Internet-based, interconnected network of interoperable data pools and a Global Registry
- The GS1 Global Registry enables companies around the world to exchange standardised data with their trading partners.

# What is GDSN?

## The GDSN consists of:

- **Trading Partners**: Suppliers, retailers, wholesalers, logistics service providers, etc.
- Data Pools Service providers that hold and process item and trading partner data
- The GS1 Global Registry: A worldwide directory to help the GDSN community locate data sources and manage ongoing synchronization relationships between trading partners





- Provides Validation Services to ensure uniqueness and basic GTIN and GLN rules
- Contains basic Party information to identify the participants and their roles
- Does <u>not</u> contain all trade item information
- Is <u>not</u> the world repository of all trade item information





- GTIN: Item information including attributes controlled by the brand owner/data source (e.g., dimensions, weights)
- GLN: Location information including locations involved in trade (e.g., headquarter, billing, ship to)
- GPC: Global Product Classification
  - A mandatory classification system in the GDSN
  - A rule set based structure (not product identification or description)
  - The Brick identifies a category incorporating trade items

# Benefits of the GDSN

### GDSN:

- Provides standardised, reliable data for effective business transactions in both local and global markets, driving costs out of the supply chain
- Ensures that trading partners and the data pools work in a standardised way thereby reducing duplicate systems and processes
- Ensures that item data is updated and consistent between trading partners
- Validates accuracy of data against standards and business rules





# Benefits of the GDSN

#### GDSN:

- Reduces costs by minimizing or eliminating non-value-added manual processes
- Save costs through efficiencies in logistics, accounting and inventory
- Provides a process to start cleaning your data via targeted implementation
- Foundation for electronic collaborative commerce initiatives such as the Electronic Product Code<sup>™</sup> (EPC). The EPCglobal Network<sup>™</sup> relies on the accurate data exchanged through global data synchronization.



## **Recommended Next Steps**

- 1. Form a HUG/GDSN work group (the collaboration)
- 2. Identify the project champion(s) (person with the passion)
- 3. Identify the project team (users who would implement)
- 4. Define the high level business need (step 1)
- 5. Develop the necessary standards (step 2)
- 6. Test the standards via a pilot (step 3)
- 7. Certify Data Pools and the GS1 Global Registry<sup>™</sup> on the approved standard (*step 4*)
- 8. Implement the solution (step 5)
