This directive created a need to develop an extension of the existing invoicing standards for European Union countries to implement these requirements.

To supply the detail design of the EU VAT business transaction needed to meet the requirements of the Invoice-European Union Value Added Tax (VAT) Extension BRAD.

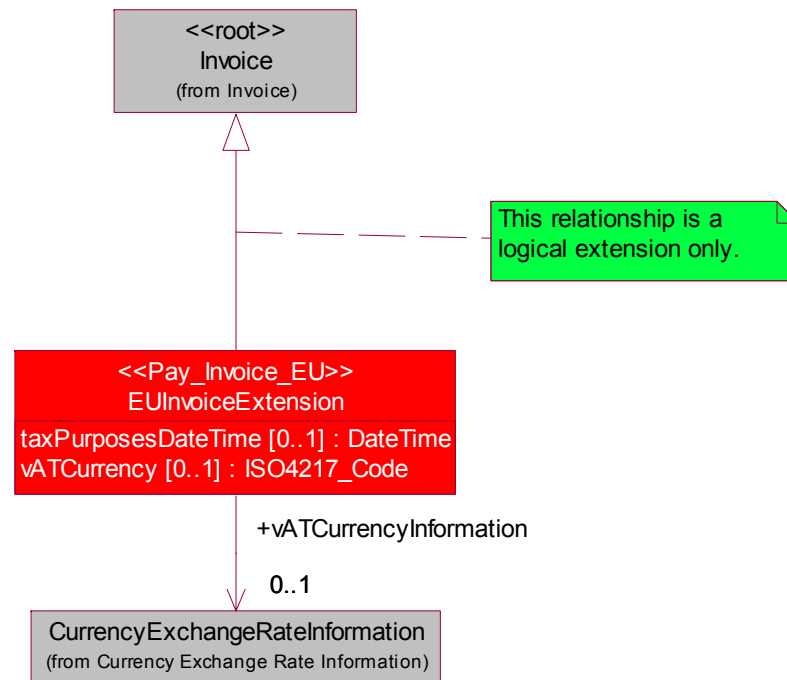

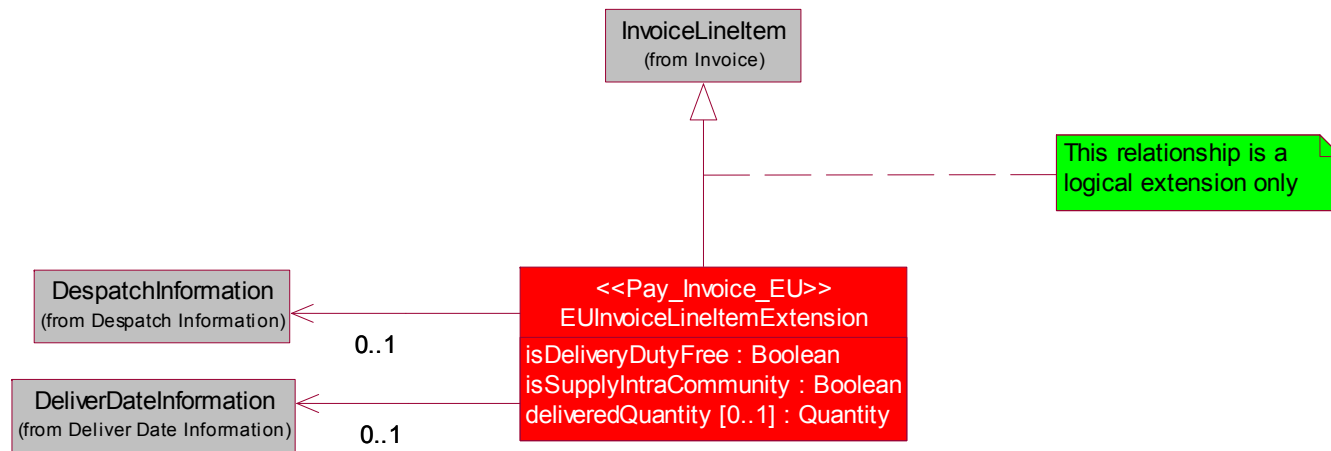
