 - Finalization of relaxation of Validation Rule 108 in the 2.8 release. Eric reached out to data pools and there seems to be no issue with the relaxation of this rule. The group asked to make sure that the rule is waived in sync by all the Data pools, the deadline should be September 2014. In the meantime interim communication should be sent to the GDSN community. HLT and Pete Alvarez should also be included in the communication, as this has an impact also on Healthcare users.
 - Handling of GPC Versions and Deletes (Poll Results) and discussion with Mike Mowad. A poll has been conducted among Data Pools. The results are posted in the Community Room: [Poll Results GPC Deletion.pptx](#). In Summary, there were two ways of dealing with the GPC Deletion have been identified:
 - i. Deletion effective immediately on release (most common).
 - ii. Codes marked for deletion and removed from the network 6 months later (grace period)In most cases any items referencing the deleted codes are updated to 99999999 until data source can assign new GPCs. Validoo does advanced planning ahead of implementation helping data source convert prior to the GDSN cut over to the new GPC release.

The group decided that some alignment is necessary with possible updates to how GPC releases are managed. Bruce Hawkins will prepare a document showing an impact of each of these options. The topic will be discussed further in Atlanta during the GPC and OTAG meetings.
