



Best Practice: Law Making Process

- Clear and timely legislation
- Ensure consistency across all regulatory documents (law, guidelines etc.)
- Involve stakeholders
 - Manufacturers
 - Wholesalers
 - Logistics service providers
 - Pharmacists
 - 0 ...



Align with Requirements Globally: Scope of Products



- Limit scope to Rx products
- Exclude
 - OTCs
 - Orphan drugs
 - Contrast media
 - Free samples
 - Radiopharmaceuticals
 - Cosmetics
 - Food supplements
 - Animal health products





Align with Global Standards

- Adhere to GS1 Global Standards for verification
 - GS1 system (numerology)
 - GS1 Data Matrix Code (symbology)
 - Max. 5 data elements
 - GTIN (Global Trade Item Number)
 - S/N (Serial Number)
 - Batch
 - Expiry
 - NHRN (National Healthcare Reimbursement Number)
- QR code for information of patients (patient information / electronic leaflet) and healthcare professionals



Align with Global Approaches: Serialization



- Manufacturers generate the serial numbers themselves
- Apply serial numbers to the secondary package
- Use of mature coding technologies (e.g. GS1 Data Matrix Code)






Select between Global Approaches: Aggregation




- What are the expected benefits of aggregation?
- Point-of-Dispense verification (EU model) vs. full Track&Trace (Turkey, Korea)
- Aggregation level: secondary packaging + shipper cases



Select between Global Approaches: Reporting



- Who operates the verification repository? Governance Model
- Authorities- vs. stakeholder-driven
- Data control vs. responsibility for data security and availability

Best Practice: Timeline

- Realistic Implementation Timeline
- Staged Implementation (increasing complexity)
 - Non-serialized coding (French coding)
 - Serialization
 - Reporting / Point-of Dispense Verification
 - Aggregation
 - Reporting / Track&Trace

Manufacturer's Implementation Challenges



- Project Execution Timeline
 - 1st line project incl. IT infrastructure approx. 24 months
 - Subsequent line projects 12-15 months
 - Artwork changes, regulatory change requests, re-registration
- CMOs
 - Technical and financial capabilities,
 - Sometimes only very few SKUs affected
 - Need for re-registration if current CMO is not capable




