



Secure data hosting for GoP data with More control











Provincial Governments and DRAP are leading to improve procurement governance & accountability

Likewise, in the same year, many patient died due to Tyno Syrup










Aligning Global Standards

Legislation

- Manufacturer, responsible entities, Exporters, or distributors would h ave a valid GS1 Company Prefix.
- Manufacturer will print the barcode labels as per GS1 Standards and DRAP requirements for different level of packaging.
- Manufactures will save GS1 standards Information in their repositories in absence of DRAP central GS1 information database before the drug release in the market.
- The export products will follow exporting country rule



Summary of Recommendations and Way Forward

- Pharmaceutical industry comply to GS 1
- Countries demand GS 1 complaint products
- Local preparedness and institutional capacity building
- Legislation enactment and enforcement
- Centralized database to effectively monitor
- Financing of pharmaceutical bar code system
